TERMS AND CONDITIONS OF HIRE

The booking customer is responsible to ensure all passengers are aware of these terms and conditions, and is also responsible for damage to exterior, interior and or contents of the vehicle.

Advertised Hire Charges

Advertised hire charges for weddings and special occasions apply to the Shepparton area. Bookings outside this area are charged at an agreed rate in addition to the standard rate. All wedding services are based on the church, house and reception venue being within a 30km radius. An extra fee may apply for outer areas.

Bookings & Confirmation

All bookings must be confirmed with a 25% deposit. The balance owing is required 14 days prior to the event. Any deposit is an acceptance of these terms and conditions.

Cancellation Policy

The 25% deposit is non refundable. The full amount is charged if the cancellation is within six weeks of the event.

Breakdown

Our vehicle is maintained to the highest possible mechanical condition as required by Transport Operator Accreditation. However, in the event of a breakdown or accident to the vehicle prior to the date of the journey every effort shall be made to supply an alternate vehicle at the Company's (Shepparton Hummer Hire Pty. Ltd.) discretion. If this is not acceptable to the hirer a refund will be made of the monies paid. If the vehicle breaks down during the journey or en-route to the customer, the chauffeur will try to make alternative arrangements. Refund may be made for the uncompleted portion of the trip only.

Access

Due to the physical size of the vehicle there may be times when it will not be possible for the vehicle to access every driveway, road or venue. The chauffeur will endeavour, where safety permits, to access all venues. However if the chauffeur deems that the safety of the passengers or vehicle may be at risk then he has the right to drop off at the nearest safest location.

Liability

The Company (Shepparton Hummer Hire Pty. Ltd.) undertakes that it shall exercise all reasonable skill, care and diligence in the performance of its duties hereunder and save for liability for death or personal injury arising from the Company's negligence or for liability, the Company's obligation to refund any monies paid directly to the Company shall constitute the full extent of the Company's liability in respect to any loss or damage sustained by the customer whether caused by breach of contract or by misrepresentation or by the negligence of the Company, its employees or agent arising from the breakdown

of any vehicles, or technical faults with the malfunction of any equipment, or any other cause whatsoever, and the Company shall not be liable in circumstances where the vehicles hired out are not fit for any special purpose unless full details of such purpose had been given in writing to the Company and the Company has acknowledged the same in writing and agreed thereto.

Insurance

We are fully insured and carry all the necessary licensing that is required. In case of any accidents our liabilities are limited to what is stated in the vehicle insurance policy.

Damage to the Vehicle

Any breakage or damage to the vehicle made by the passengers will be charged to the person who made the booking. If an individual is physically sick in the vehicle the charge will be the actual cost for valet-service which may also include detailing. A minimum charge of \$200.00 applies. We recommend having fun with decency.

Misbehaviour

The chauffeur has the right to stop the vehicle and ask any persons to leave if they mistreat the vehicle in any way. No one is allowed to hang out or shout abuse out of the vehicle or windows.

Smoking

Smoking is not permitted in the vehicle.

Fast food items

Fast food meals may not be eaten in the vehicle.
